Requested Documentation to Receive Credit

Now for Your Future Gift

Notifying the Foundation about your future estate gift allows us to have a conversation now about how you would like us to use your gift in the future. If you are age 65+, you may also be eligible to receive campaign credit now for your future gift. To determine your eligibility, the Mary Lyon Foundation requests that you provide written documentation along with the signed Bequest Intention form.

Documentation may be submitted in the form of mailed photocopies, or emailed scans, computer screenshots, or legible photographs (including by cell phone) of estate-related documents that detail your future intention to support the Foundation. After reviewing the submitted documentation, the Foundation will notify you of your eligibility for donor credit to be awarded during your lifetime for your estate gift.

The Foundation fully respects the private and confidential nature of your estate plan. References to other beneficiaries may be redacted on the paperwork you provide to us. Documentation is not necessary in order to maintain membership in the Putnam Hill Legacy Society, only to receive campaign credit.

To properly record your intention, the Foundation respectfully requests:

- 1. This Bequest Intention form, completed and signed on the opposite side; and
- 2. Documentation of your intended gift to the Foundation.
